- I. The Hyderabad Urban Development Authority (HUDA) invites Qualification and Financial Proposals from interested Bidders for **Design, Construction, Development, Finance, Operation and Maintenance of Eight lane access controlled Expressway under Phase II A Programme as an extension of Phase I of Outer Ring Road to Hyderabad City , in the State of Andhra Pradesh, India, for the Projects/Packages detailed in the table below on Build, Operate and Transfer (BOT) (Annuity) basis** for a Concession Period of 15 years (180 months) including the Construction period of 2 ½ years (30 months).

- II. The Scope of work for each of the Project detailed in the above table includes Design, Construction, Development, Finance, Operation and Maintenance of the Project on BOT (Annuity) basis.
- III. Interested parties may obtain the Bid Documents/ Request for Proposal Documents (the “RFP” document) for the Projects at S.No. 1 & 2 from **28th February, 2007 to 12th April, 2007** and for the Projects at S.No. 3 to 5 from **28th March, 2007 to 14th May, 2007** respectively from the address given at S.No. IX below on all working days between **10:30 hours and 17:00 hours IST** by written request.
- IV. The request must clearly state “Request For Proposal for Project No. and stretch of the project” as detailed above and be accompanied by a non-refundable fee of **Indian Rupees Rs. 50,000/- (Rupees Fifty thousand only)** by way of crossed Demand Draft (non-refundable) drawn in favour of ‘**Hyderabad Growth Corridor Ltd.,(HGCL)**’ payable at Hyderabad, for each of the Project separately.
- V. HUDA will not be responsible for any delay, loss or non-receipt of Bid Document/ RFP Document sent by post / courier. Further, HUDA shall not be responsible for any delay in receiving the proposal and reserves the right to accept / reject any or all applications without assigning any reason thereof.
- VI. The Bid document / RFP document contains information about the Project, Scope of work, Qualification requirements, bidding process, Proposal submission, Technical and Non-Technical Schedules, Concession Agreement, etc. The Bid Documents / RFP documents for the projects are also available on the websites **<http://www.hudahyd.org> & www.hyderabadringroad.com**. Bidders, who download the RFP documents from the website, will be required to pay the non-refundable fee of **Rs. 50,000/- (Rupees Fifty thousand only)**, by way of a crossed Demand Draft (non-refundable) drawn in favour

of 'Hyderabad Growth Corridor Ltd., (HGCL)' payable on any scheduled bank in Hyderabad , at the time of the submission of the Proposal for each of the Project separately.

VII. Further, all three parts of the Proposal (Other Submissions, Qualification Proposals, Financial Proposal) must be submitted in a hard bound form separately (hard bound implies binding between two covers through stitching or otherwise whereby it may not be possible to replace any paper without disturbing the document - spiral bound form, loose form, etc. will not be accepted) with all pages numbered serially, along with an index of submissions. Applicants are required to submit all information / details in the format prescribed in the document. In the event of any instructions mentioned herein have not been adhered to, HUDA reserves the right to reject the application. All figures quoted in the Financial Proposal should be covered with a transparent adhesive tape.

VIII. All Bids / RFP must be delivered not later than **12:00 hours IST on 13th April, 2007** for the Projects at S.No. 1 & 2 and on **15th May, 2007** for the Projects at S.No. 3 to 5 in the manner specified in the Bid document / RFP document at the address given in the Serial No. IX. All bids must be accompanied by Bid Security specified in the RFP.
